MEMORANDUM

TO: Customers

FROM: Spalding County Water Department

RE: Pressure Reducing Valve

This is to inform you that the Spalding County Water system has 40 PSI to 140 PSI pressures throughout our system. With these types of pressures, we recommend you consider installing a Pressure Reducing Valve on your lines while hooking on to the County Water System. The Southern Building Code requires the design of the water fixtures to accommodate 60 – 80 PSI of constant pressure. So you can see that the plumbing fixtures are not going to last as long as designed if your area has a high PSI.

Therefore, we are suggesting you install this PRV device while hooking on to the system to prevent any further expense from blown lines and pipes. This will also keep your fixtures from wearing out before their time.

This PRV device can be installed fairly simply while hooking up and the average cost ranges from \$35.00 to \$65.00.

SPALDING COUNTY WATER RATES

EFFECTIVE FEBRUARY 1, 2019

The following are the current water rates for county customers. The minimum rate is \$13.71 per month, plus \$7.95 for each thousand gallons you use up to 7,000 gallons. Each thousand gallons you use over 7,000 gallons up to 10,000 gallons will cost \$9.94. Each thousand gallons you use over 10,000 gallons will cost \$10.89.

Example: If you use 7,000 gallons a month (which is the average consumption) Your water bill will be \$69.36. Depending on how many gallons you use, you will pay more or less than this amount, which gives you an incentive to conserve.
