The Spalding County Board of Commissioners held their Extraordinary Session on Monday, July 17, 2023, in Room 108 of the Spalding County Annex Building, beginning at 6:00 p.m. with Chairman Clay Davis presiding. Commissioners Rita Johnson, Ryan Bowlden and James Dutton were present for the meeting. Commissioner Gwen Flowers-Taylor joined the meeting at 7:02 p.m. via ZOOM. Also present were County Manager, Dr. Steve Ledbetter, County Attorney, Stephanie Windham and County Clerk, Kathy Gibson to record the minutes.

- ✓ Thanked T.J. Imberger for his outstanding presentation and the work that he and his staff have done on their dashboard and scorecard.
- ✓ Advised that beginning tomorrow Neighborhood Comfort Stations/Cooling Centers would be open at Ambucs Community Center and the Flint River Regional Library. Effective July 22, cooling stations will be open at the Fairmont Community Center and City Park Community Center as well.
- ✓ A Beat the Heat/Back to School Bash is planned for the Carver Road Fire Station on July 29<sup>th</sup> from 12:00 – 2:00 p.m.
- ✓ T-SPLOST Update The first year of collections are +9% higher than anticipated and this allowed staff to purchase some of the Tire 2 Items approved at the time the T-SPLOST was voted on.
- ✓ The Spalding County Tax Assessors' Office has reported the total number of appeals filed for this digest year is 1,238 which is 3.4% of the total digest.

## Ryan Bowlden –

- He was surprised to hear the low number of appeals filed over the Tax Assessments as he has received a number of emails and calls about the assessments and inflated values. This is their opportunity to fight, and they are not taking the opportunity.

#### James Dutton –

- He felt the 4<sup>th</sup> of July parade was a success. It was well attended, and he feels like the number of people who attend will continue to grow now that it has moved back to Downtown Griffin.
- He updated the Board on water parks that he and his family visited in Greenville, South Carolina. Their county has three water parks, which includes pools, slides and one had a lazy river. They took him behind the scenes to show him how things were working and showed him their numbers. They even said they would be willing to come down and give us their expertise on splash pads.

### Clay Davis -

- The 4<sup>th</sup> of July Parade was a great success, and we have to continue to work on it. As we continue to have it downtown it will become better.
- We have taken a huge step forward on the dashboards. The staff learning how use dashboards will pay huge dividends in the future.
- We have a Behavioral Crisis Center in our area that services seven counties in our area. Chairman Davis will set up time for the Board of Commissioners to visit the Center, it will take less than an hour. Chairman Davis encouraged the Board to learn more about the Center.
- We have several meetings that we need to schedule. One is the telephone system RFP Bids and the Aquatic Center RFP.
