

After Agenda Board of Commissioners – Regular Meeting August 7, 2023 6:00 PM Room 108, Spalding County Annex Building 119 E. Solomon Street Griffin, GA 30223

The Spalding County Board of Commissioners held their Regular Meeting on Monday, August 7, 2023, in Room 108 of the Spalding County Annex Building, beginning at 6:00 p.m. with Chairman Clay Davis presiding. Commissioners Rita Johnson, Ryan Bowlden, Gwen Flower-Taylor, and James Dutton were present for the meeting. Also present were County Manager, Dr. Steve Ledbetter, County Attorney, Stephanie Windham and County Clerk, Kathy Gibson to record the minutes.

I. OPENING (CALL TO ORDER)

X. REPORT OF COUNTY MANAGER

- ✓ Dr. Ledbetter thanked Chief Polk for working diligently with GEMA/FEMA to recover funds to pay for the damage the county suffered during the January 12th tornados.
- ✓ Presented a TSPLOST Update.
- ✓ Advised that severe weather is moving through our area this evening and tomorrow and asked that everyone be weather aware.

XI. REPORT OF COMMISSIONERS

<u> Rita Johnson</u> –

- Thanked Chief Polk for a great presentation.
- Stated that she has been very impressed by the Dashboards that have been presented so far and feels that they are beneficial in assisting the Board of Commissioners in understanding what is happening within each department of the County.
- Asked about the bids for the Fairmont Project.

<u> Ryan Bowlden –</u>

- Gave an updated he received from the Tax Assessors Office, there are now 2,157 appeals that have been filed out of 33,090 parcels in Spalding County. He is glad to hear the number of appeals have increased, but stated that he is perplexed as to why more people aren't following the process.
- Ask for a time to speak with Dr. Ledbetter about the "Old Pension Plan" that many of the longer term employees were under and how these employees can qualify for a longer term on the current pension plan.
- Has received a number of complaints on homes in his district being utilized by Air BNB customers. These complaints center around homes being rented and the renters throwing large parties at the location. Asked that staff look for an ordinance that could be enforced regarding Air BNB customers using homes for party houses and disturbing others in the area.

<u>Gwen Flowers-Taylor</u> –

- Agreed that there needs to be some serious thought put into the Air BNB industry in Spalding County and how we can prevent the partying that disrupts a neighborhood.
- Asked for an update on the Animal Control Policy and the Animal Shelter Policy as staff has been working on both of these policies.
- Would like to see some type of promotion of a robust outreach program to allow people who witness trucks on roads marked as No Thru Truck to easily report there are trucks utilizing the roads.

<u> James Dutton</u> –

- Wanted to reiterate to all of the citizens that the Collection Centers are NOT closing.
- Asked if Nuisance Enforcement for the Noise Ordinance was being enforced. He was assured by Dr. Ledbetter and Sheriff Dix that the Noise Ordinance was being enforced.
- Asked when the new version of Municode would be available. Dr. Ledbetter stated that staff had been notified it should be available by the end of the month and that he would make sure that Commissioner Dutton was copied on it as soon as it is received.

<u> Clay Davis</u> –

- Thanked everyone who participated in the Carver Road Fire Station community event.
- He also thanked everyone who participated in the Day One Event at the schools this year.
- Inquired about a possible Golf Cart ordinance. As new areas open up there appears to be more golf card traffic on the roads.
